Consulting Package — Providers (2 hours)	<ul style="list-style-type: none"> • Up to two hours of one-on-one support, mentorship and coaching with a Registered Early Childhood Educator (RECE) • Develop strategies to meet Ministry of Education Regulations for Child Care and Early Years Act, 2014 (CCEYA) • Develop or Review Health and Safety Guidelines • Complete a full “Quarterly Check” (Ministry of Education requirement for licensed providers) to self-evaluate your program • Receive a certificate of participation • Discuss your program planning • Look at small business set up (what contracts, policies and deductions could you be using to make you money) • Open discussion on behaviour implementation strategies, general concerns, and parent interactions • Receipt issued for tax deduction 	<p>\$75.00 (May be an increased fee for mileage. Consulting Package — Parents (2 hours)	<ul style="list-style-type: none"> • In home consultation with a Registered Early Childhood Educator (RECE) to discuss your childcare needs • Register your child on waitlists for preferred licensed home childcare and childcare centres in your area • Provide contact information of independant care providers in your area as well as priority access to Natural Connections Childcare (NCC) waitlist and registry • Provide you with a list of questions and what to know when looking for childcare • Accompany you on a match visit with potential provider should you like another set of eyes (Visits \$50 each) • Information and support on how to prepare you and your child for care including a pamphlet on how to prepare you and your child for care • Quarterly newsletter and invitations to parent workshops • Access to an RECE for support and questions about care and child development • Developmental check sheet completed with you and an RECE 	<p>\$75.00</p>

Platinum Provider Package — Affiliation with Licensed Agency (Yearly Fee for Contracting Service)	<ul style="list-style-type: none"> You maintain your own contracts with parents, set and collect your fees (No administrative fees) You choose your own rate of pay, hours, days of operation and holiday days You may qualify for Wage Enhancement Grants of \$20 per day (\$400 per month) Assistance in developing strategies to meet Ministry of Education childcare regulations that suit you and your home childcare philosophy (Child Care and Early Years Act, 2014) Quarterly visits from a Registered Early Childhood Educator (RECE) to help you with your licensing requirements and questions Access to an RECE for questions and support — emails and phone calls (FREE) Invitation to training events, networking nights and Natural Connections Childcare (NCC) online provider group Access to a sixth child (helps with the overlaps, snow days and after school times) Access to other government funding Registered on NCC childcare page and listing Access to a Group Pension Plan Tax receipts issued. As this is a purchase of service and not an administrative fee at source you may be able to use this fee as a business deduction 	Providers Purchase of Service: \$250 per month (Only \$12.50 per day) No administrative fee per child Potential qualification for Wage Enhancement Grants of up to \$400 per month Annual fee can be used as a tax deduction
